Pacem in Maribus Conferences

The International Ocean Institute organises *Pacem in Maribus* conferences annually to provide a forum where the challenges of ocean space can be considered in their interconnectedness. 34 such conferences have been held to date around the globe, and they have become respected as important events in understanding threats to the world's oceans as well as the potential of ocean resources to sustain humankind.
